Helen Rowell was appointed as Deputy Chair of APRA in November 2015, and reappointed for a further five-year term from 1 July 2018.

Mrs Rowell joined APRA in 2002 as General Manager, Industry Technical Services and held a number of senior roles, including General Manager, Diversified Institutions Division, General Manager, Policy Development and Executive General Manager, Supervisory Support Division prior to her appointment as APRA Member, with primary responsibility for superannuation, from 1 July 2013.

Mrs Rowell was the Chair of APRA's (crossdivisional) general insurance industry group from 2006 to 2011, and has represented APRA at various subcommittees of the International Association of Insurance Supervisors, on the FSB's Supervisory Intensity and Effectiveness Group and was previously co-Chair of the Joint Forum Financial Conglomerates Committee. Mrs Rowell is currently the APRA representative on the OECD Working Party on Private Pensions, and was appointed President of the International Organisation of Pension Supervisors in November 2019.

Prior to joining APRA, Mrs Rowell was a partner at the international consulting firm Towers Perrin; she is also a Fellow and past President of the Institute of Actuaries of Australia.

Christian Thimann is CEO and Chairman of the Management Board of Athora Deutschland Group and is responsible for Athora's overall activities in Germany.

Prior to Athora, Christian was Group Head of Strategy at AXA Group in Paris from 2014 until 2016 and a Member of the Group Executive Committee where he coordinated AXA's global strategy in life insurance, general insurance and asset management. Christian was also a Member of the Board of Directors at AXA's asset managers, Alliance Bernstein Investment and AXA Investment Managers. He was also responsible for matters concerning European and international insurance regulation.

Christian also worked in an executive position at the European Central Bank until 2013, most recently as Director General. Christian has also been Chairman of the EU High-level Group on Sustainable Finance and is the Vice-Chair of the FSB Task Force on Climate-related Financial Disclosures.

Mr White has over 30 years' experience from the private sector and public authorities in Australia. Most recently, he was the inaugural Chief Executive Officer of Chartered Accountants Australia and New Zealand (CAANZ), where he played a central role in bringing together the Institute of Chartered Accountants Australia (ICAA) and the New Zealand Institute of Chartered Accountants to form CAANZ in 2014. From 2004 to 2009, he worked as Chief Accountant at the Australian Securities and Investments Commission (ASIC), where he provided oversight and supported Australian companies in their transition to IFRS Standards. He was also a member of the Australian Financial Reporting Council and the Australian member of both the International Organization of Securities Commissions and the International Forum of Independent Audit Regulators. Prior to joining ASIC, he served as Assistant Auditor-General at the Audit Office of New South Wales from 1994 to 2004 and as an Audit Principal with PwC (then Coopers & Lybrand) from 1984 to 1994. Mr White

has a Bachelor's degree from Macquarie University in Sydney, Australia. He has been a Fellow of ICAA since 1998.

#### Mr Frank Elderson

Frank Elderson is a member of the Executive Board of the European Central Bank. He oversees the ECB's Legal Services and is Vice-Chair of the ECB's Supervisory Board.

Mr Elderson previously served as Executive Director of De Nederlandsche Bank (DNB). At DNB he held several senior positions before joining its Governing Board in 2011.

Government insurance, investment funds, financial integrity, prudential regulation, capital controls and flows, first tier banking and financial inclusion. He has represented the National Treasury at the G20 Financial Access Working Group, Financial Sector Charter and Nedlac processes. He is currently the Divisional Executive: Retirement Funds Supervision at the Financial Sector Conduct Authority (previously the Financial Services Board).

Charles Counsell was appointed Chief Executive of The Pensions Regulator (TPR) on 1 April 2019.

Prior to this Charles was Chief Executive at the Money Advice Service for nearly two years. Charles spent six years before this as Executive Director for Automatic Enrolment at TPR where he was responsible for the successful roll-out of this programme across the UK, working alongside the Department for Work and Pensions (DWP). In his time at TPR, the automatic enrolment programme led to over 7.5 million workers newly saving into a workplace pension from over 500,000 employers.

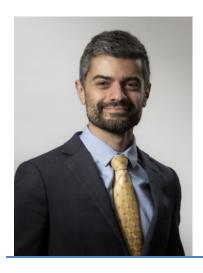
Charles was awarded an OBE in 2017 for services to workplace pension reform.

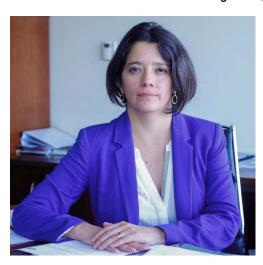

Ms Alice Law is the Deputy Chairman and Managing Director of the Mandatory Provident Fund Schemes Authority (MPFA). Ms. Law is a Senior Fellow of the Hong Kong Securities and Investment Institute, Member of Green and Sustainable Finance Cross-Agency Steering Group, Member of Council of Advisors for Applied Research of the Hong Kong Institute for Monetary and Financial Research of the Academy of Finance, Co-chair of Global Future Council on Responsive Financial Systems of World Economic Forum, and MPFA's official representative to the International Organisation of Pension Supervisors (IOPS) Executive Committee and Technical Committee.

She was Chief Operating Officer and Executive Director of MPFA from 2012-18. She held Director to Senior Director positions at Securities and Futures Commission with last position as Senior Director (Policy, China & Investment Products). She was a partner in a Hong Kong law firm before joining the public sector in 1998.

Dr. Olga Fuentes is a pension and labor expert with extensive experience in the global research, regulation and supervision of pension unemployment insurance systems. He manages the research and policy programme of the OECD Working Party on Private Pensions (<a href="http://www.oecd.org/daf/fin/private-pensions/">http://www.oecd.org/daf/fin/private-pensions/</a>), WPPP, a body that brings together policymakers, regulators and the private sector of almost 40 countries around the world. His work covers issues related to the operation and regulation of funded retirement income systems.

The WPPP work aims at providing policy makers with policy guidelines to improve retirement outcomes. It focuses on the design of funded pension systems, its contribution to retirement income adequacy, and the regulatory framework. The work includes collecting and disseminating standardised pension fund statistics, the OECD Core Principles of Private Pension Regulation, and the OECD Roadmap for the Good Design of DC Pension Plans. The main publications are the OECD Pensions Outlook, Pension Markets in Focus and Pension Reviews and monographs on specific retirement issues.

Mr. Antolín has a PhD in Economics from the University of Oxford and an undergraduate degree in Economics from the University of Alicante (Spain).
