Practical Information

Language

The official language of Iceland is Icelandic.

Time

Iceland is on Greenwich Mean Time (GMT).

Currency

The official currency is "króna" (ISK).

Exchange: The rate is 1 Euro \approx 168 ISK, 1 USD \approx 122 ISK. Bank opening hours are generally 09.00 – 16.00 hours. All major credit cards are accepted in Iceland. More information including exchange rates is available at:

Health

No immunizations or special health precautions are necessary or required. Iceland has no infectious risks and there are no poisonous insects.

Climate

Iceland has a cool temperate ocean climate: cool in summer and fairly mild in winter.

In late February/early March the average temperature in Reykjavik ranges from -0,2°C to 0,8°C. Sunrise on the 1st of March is at 08:36 and sunset is at 18:45.

When travelling in Iceland you should bring along lightweight woolens, a sweater or cardigan, a rainproof (weatherproof) coat and sturdy walking shoes. More information on weather in Iceland: http://en.vedur.is/

Electricity

Iceland's local voltage is 220 V, 50 Hz and the sockets take the standard continental European dual round-pronged plugs. A plug adaptor is required for non-European appliances.

Tipping

Service and VAT are invariably included in prices in Iceland.

Insurance

Citizens of Scandinavia have to show passport in case of medical emergency. Citizens of EEA countries must have the E-111 form, otherwise the patient will be charged in full. Citizens of other countries must be charged in full.
